

# Silver Belt Lode.

Notice of location of the Silver Belt Ledge or Claim containing lead silver and gold, and located as a silver and gold mine-

The undesignated Claim for mining purposes fifteen hundred feet of the quartz ledge in length along the ledge or vein, and three (300) hundred feet on each side of the middle of the vein at the surface, together with all the dips, spurs and angles, <sup>and</sup> all valuable mineral deposits contained therein, and all timber growing within the limits of said Claim, and all water and water privileges thereon or appurtenant thereto, under and according to the provisions of an act of Congress, approved May 10<sup>th</sup> 1872, An Act to promote the Development of the Mining Resources of the United States."


