 where I set a Post 5 1/2 ft long 4 in.
 sq. 1 1/2 ft. in ground and build
 around it a monument of earth
 and stone 4 ft. at base and 8 ft
 high. (both posts stand together

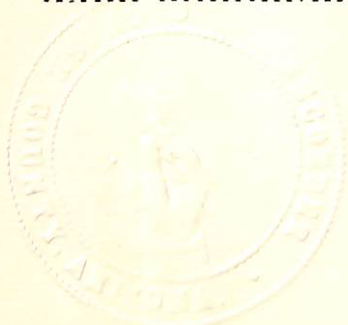

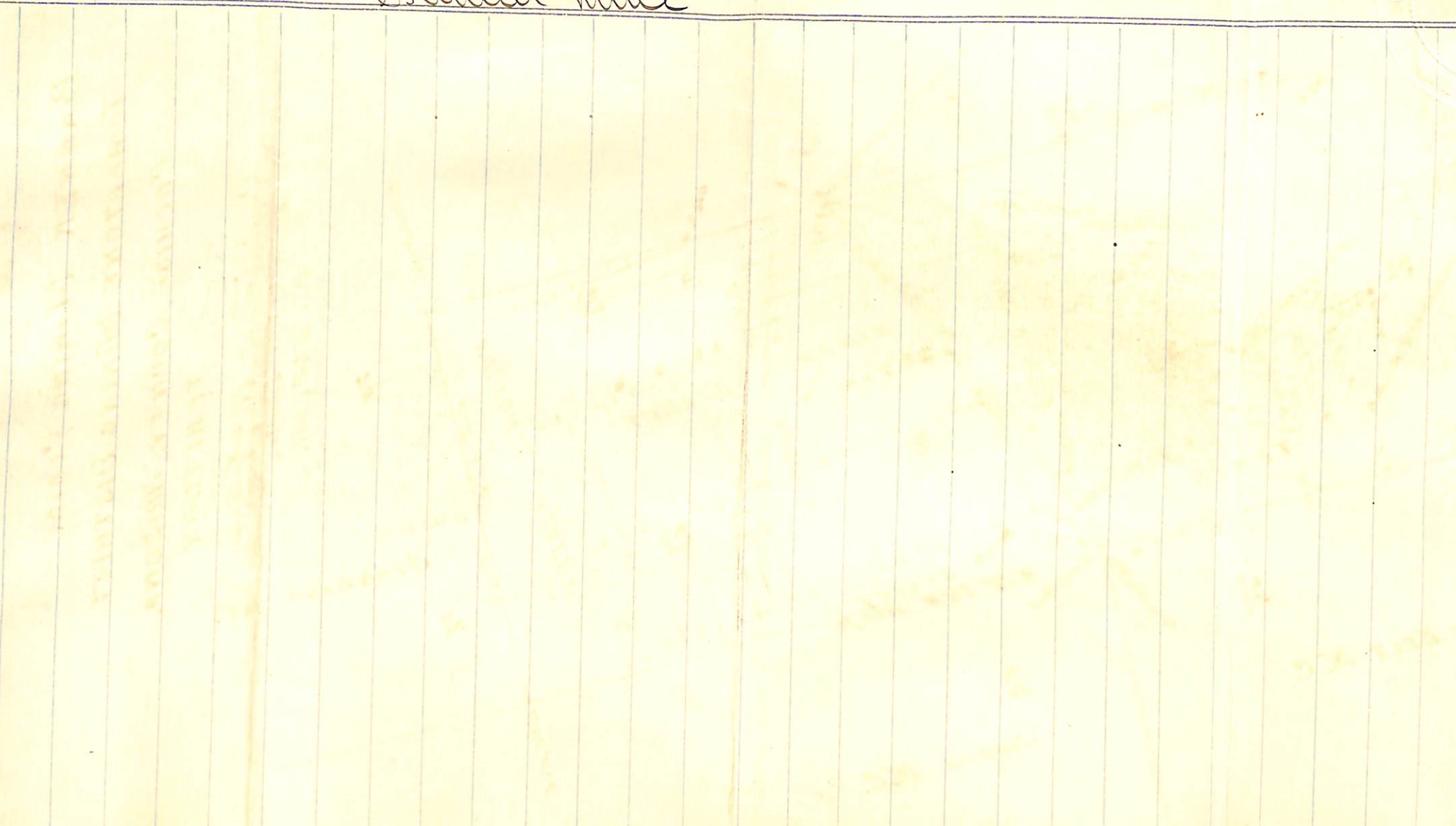

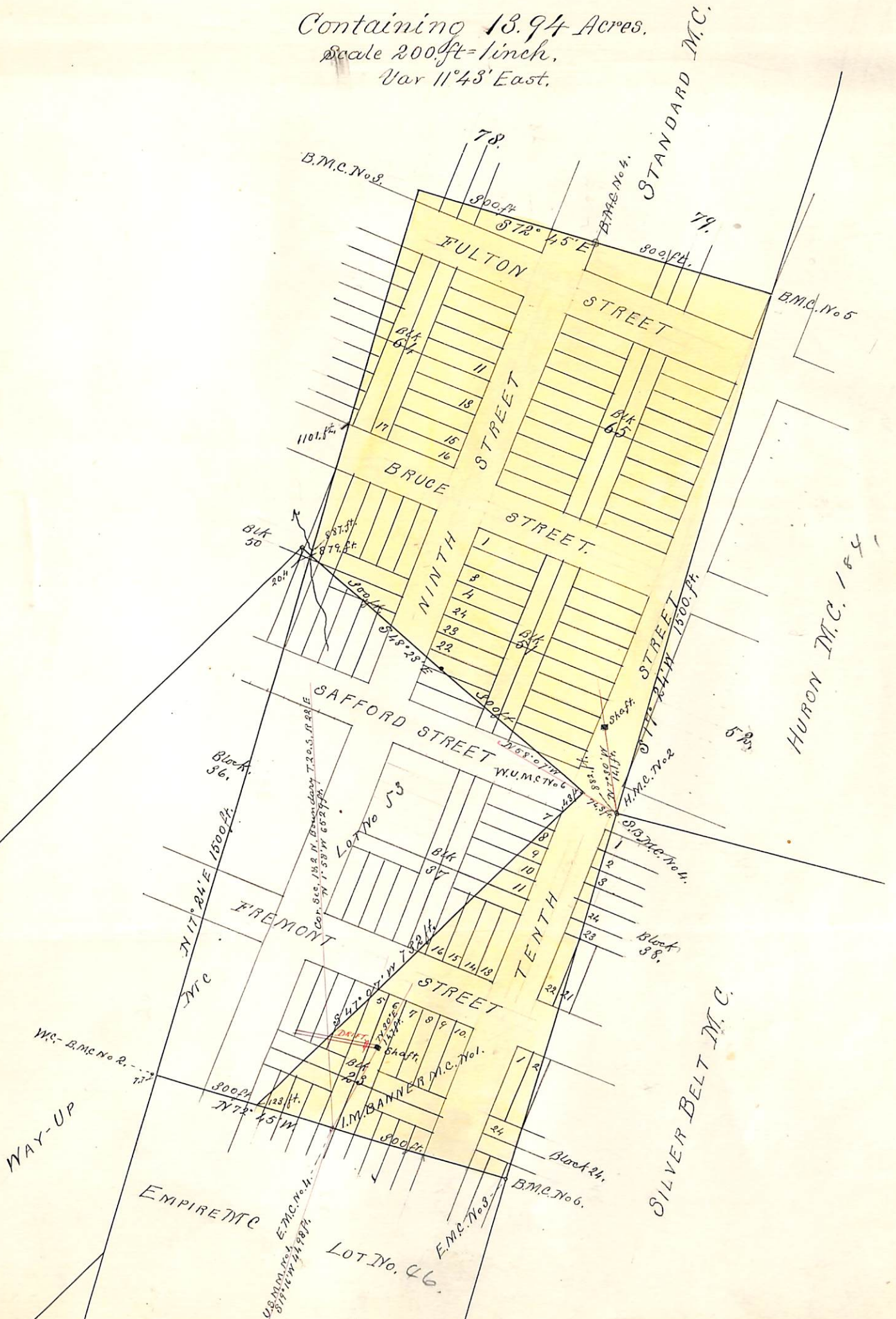


PLAT
