The undersigned under the provisions of the several Acts of Congress relating to the development of the mineral resources of the United States, hereby locate and claim fifteen hundred feet in length on this lode vein or deposit of mineral bearing quartz or other rock in place, with three hundred feet in width on each side of the middle of said lode vein or deposit for mining purposes.

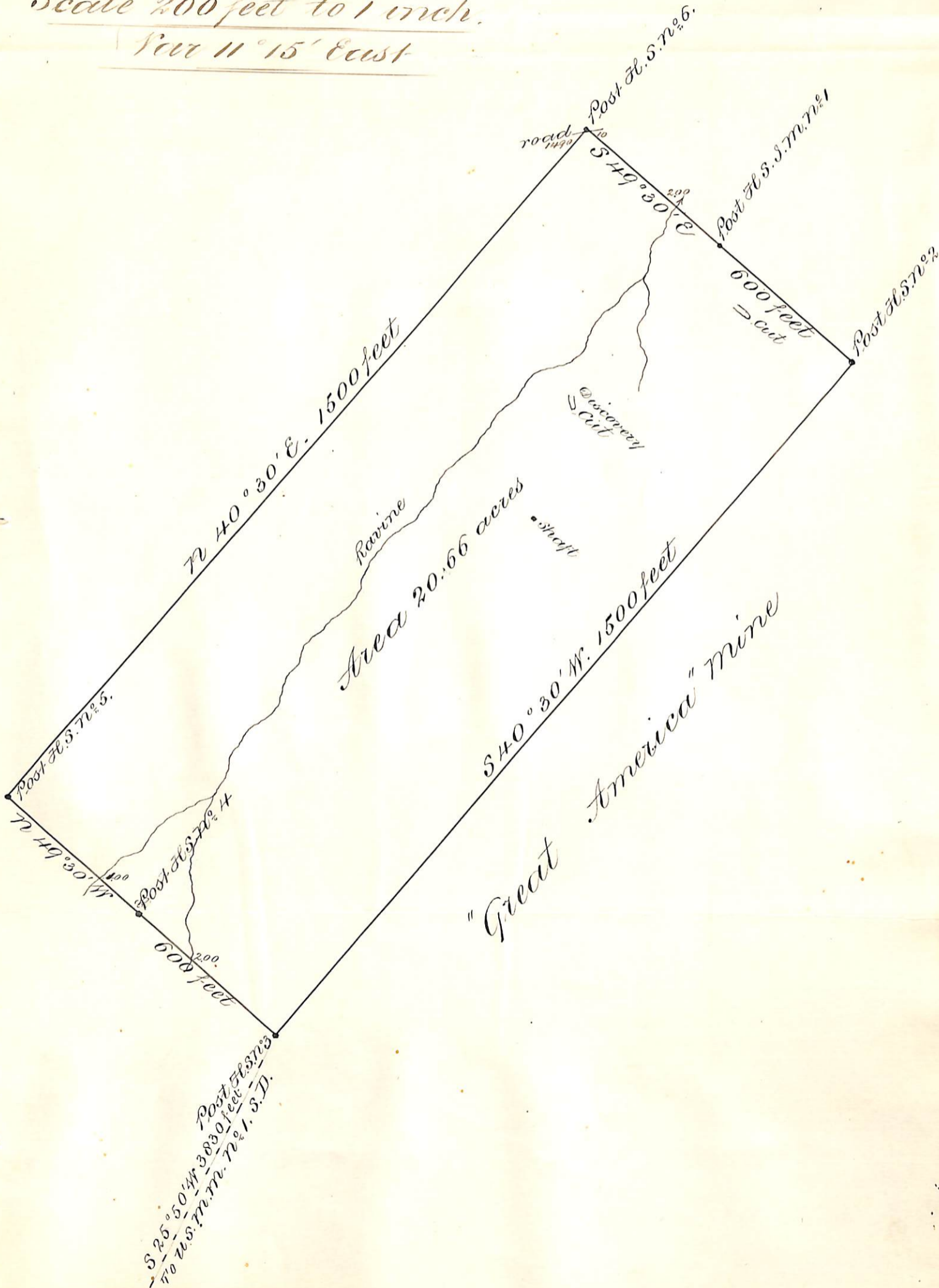
