

To All Whom It May Concern.

To all whom It may Concern:

This mining claim the name of which is the Labrador Mining Claim, situate on lands belonging to the United States of America, and in which there are valuable mineral deposits, was entered upon and located for the purpose of exploration and purchase by M. J. Brophy and E. B. Mason the undersigned, on the 25th day of April 1896.

The length of this claim is Fifteen Hundred (1500) feet, and I claim Five hundred eighty (580) feet in a North easterly direction and nine Hundred Twenty (920) feet in a South westerly direction from the center of the discovery shaft, at which this notice is posted, lengthwise of the claim, together with Three Hundred (300) feet in width of the surface grounds, on each side of the center of said claim.

The general course of the lode deposit and premises is from the Northeast to the South west.




