Instrument

This survey was made with a Gouley
Light Mountain Transit. The courses
were deflected from the true Meridian
as determined by direct solar observa-
tions. The distances were measured
with a 200 ft. steel tape.

Note. The disagreement between these field
notes and the location certificate, with regard
to the position of the discovery point,
and the courses of the boundary lines,
are due to errors in the latter.

So far as can now be determined
the center of the vein lies in the
center of the claim as surveyed,
1165.10 ft. in length bearing $N. 69^{\circ}40' E$.
