This survey was made with a Kewley light mountain transit.

Jan. 15th at 11:40 P.M. I observed Polaris at western elongation, and established a true meridian. Which I produced to intersect the side lines of claim to check my solar observation. The needle reads $N. 13^{\circ} 44' E$ for the variation, and at the intersection the angle is $58^{\circ} 10'$ S.E. for the south side line, the end lines are run at right angles to the side lines.

The distances were measured with a 100 ft. steel tape.

The disagreement between these field notes and the location certificate of this claim with regard to the position of discovery shaft, and the courses and distances of the boundary lines, are due to errors in the latter.

The corners of this survey are all within the boundaries of the location as marked on the ground.

The S.W. cor. was made No. 1, because the S.E. corner, nearest to the M.S. T.M. was in an inaccessible place and was not set.

The Course of the vein in this claim is $S. 58^{\circ} E$. as nearly as can be determined, from surface croppings. Which extend full length of claim, 1500 ft. This claim is joined by the "Mercury" on the N. "Gold King" on W. "Cacti" South, unsurveyed claim owned by Claimants, and an E. by "Dorva", unsurveyed, owned by Chas. Wilcutt.

of the needle to be $13^{\circ} 44' E$, and later ~~the~~
produce to intersect the side lines, to check
the accuracy of Solar observations, and find
the angle at intersections to be $N. 58^{\circ} 10' W$.
and $S. 58^{\circ} 10' E$.

observations, Jan. 18, 1902 at 9 A.M.,
my watch set with chronometer.

NOTICE OF MINING LOCATION.

TO all whom it may concern:

This mining claim, the name of which is the OLYMPIA (abandoned property) Mining Claim, situate on lands belonging to the United States of America, and in which there are valuable mineral deposits, was entered upon and located for the purpose of exploration and purchase by G.M. MURPHY the undersigned, on the 2nd day of January 1900.

The length of this claim is fifteen hundred feet, and I claim 135 feet in a North-west direction and 1375 feet in a South easterly direction from the center of the discovery shaft, at which this notice is posted, lengthwise of the claim, together with Three hundred feet in width of the surface grounds, on each side of the center of said claim. The general course of the lode deposit and premises is from the North-west to the South-east.

The claim is situated and located in the Black Rock Mining District, in Yavapai County, in the Territory of Arizona, about one half mile in a westerly direction from Mahona, Peak.


