
LOCATION

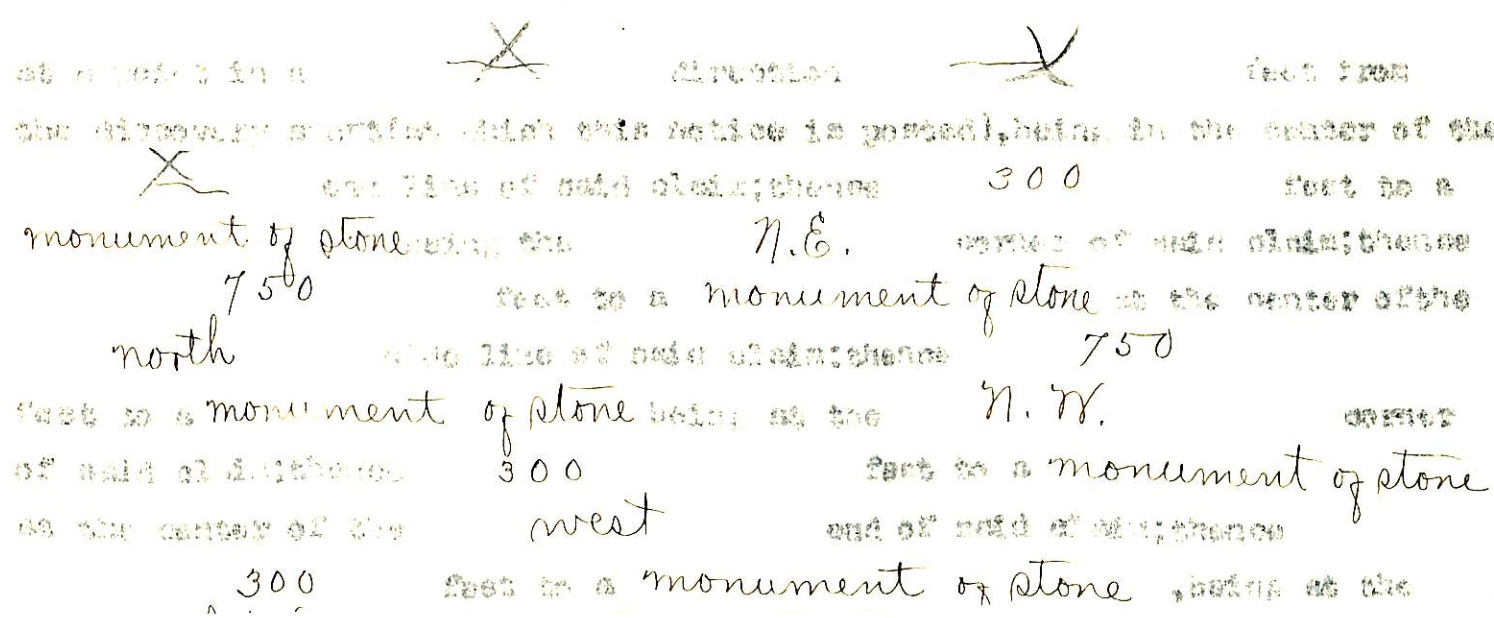

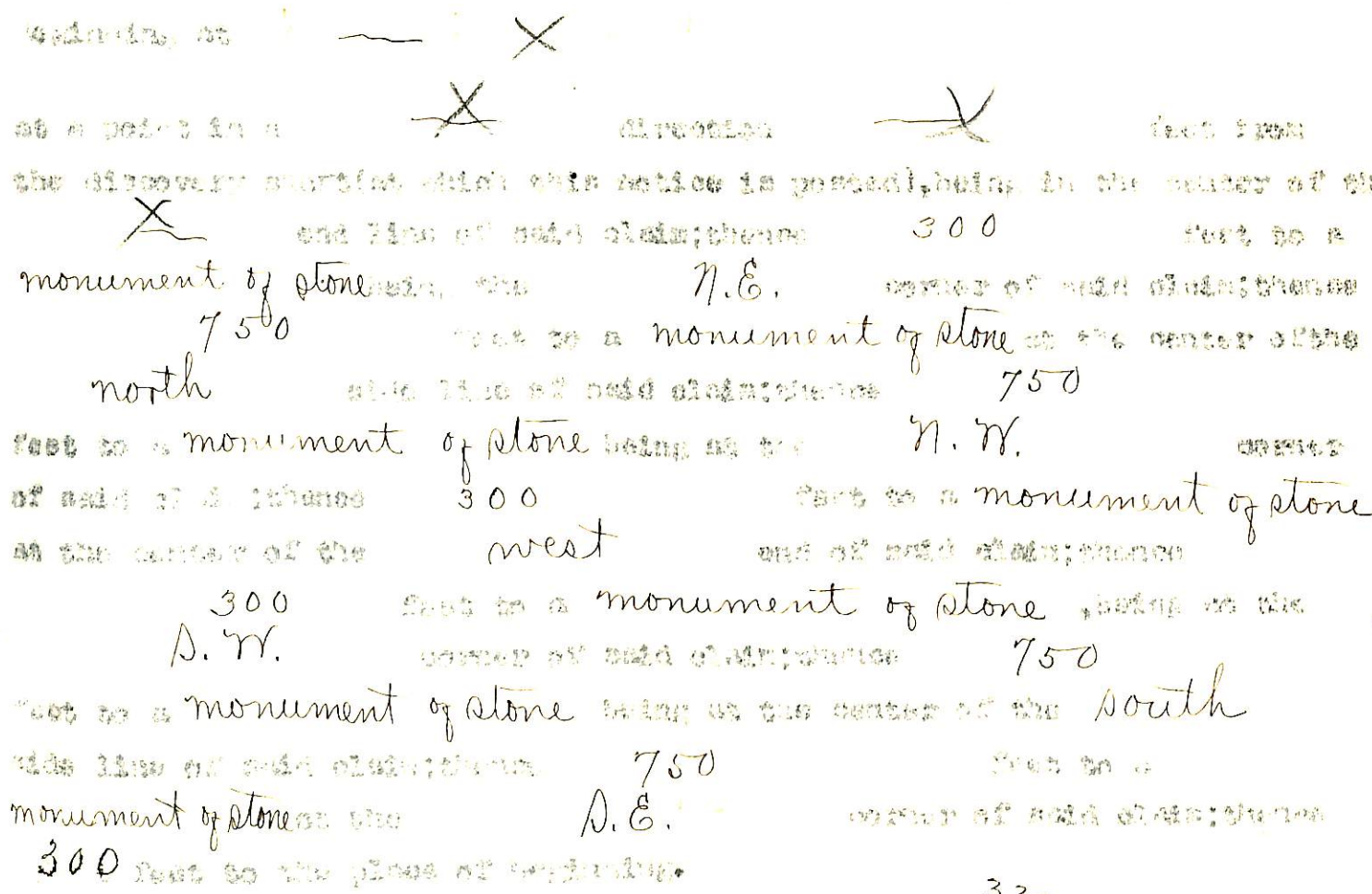

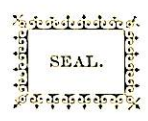
