INSTRUMENT

This survey was made with a Gurley Light Mountain Transit. The courses were deflected from the true meridian as determined by direct solar observations and checked by a meridian determined by Polaris. The distances were measured with a 100-ft. steel tape.

POLARIS OBSERVATION.

December 1, 1905. At Cor. No. 1 of the Concord Lode at 2 h 37 m. a.m., l.m.t., I observe Polaris at western elongation, and mark the line by an iron rod 5 ft. long set 300 ft. N. of said Cor.

At 7 h 30 m., l.m.t., I deflect the azimuth of 1° 26' to the E., and from the meridian thus established I check the courses of the line determined by solar observations and they practically agree.

NOTE:

Although this lode appears to be situated in a sub-divided township, there are no corners to be found, therefore I connected this survey with Mineral Monument No. 2180.

SUPPLEMENTAL REPORT FOR CONNECTING LINE OF MINERAL  
SURVEY No. 2179.

When I first went to the field and executed Survey No. 2179, Concord Lode, I made a diligent search for the corners of the public survey, which I knew should be in place, as T. 5 S., R. 16 E. was officially surveyed, but after a diligent search, I was unable to find any of the public land corners, and I determined that there was no corner of the public land survey to be found within a radius of two miles; and I therefore connected Corner No. 1 of the Concord Lode with U. S. L. M. No. 2130, and established Corner No. 1 at the corner nearest to the Mineral Monument. On filing my notes in the office of the Surveyor-General for Arizona, I was advised that it would be necessary, under a recent ruling of the Department to connect a corner of this survey with a corner of the public land survey. If no corner could be found within a radius of two miles, or within a reasonable distance over two miles, it would be necessary for me to connect with the calculated point of the nearest corner of the public land survey. I therefore returned to the field, and upon a further investigation, based on information obtained from Mr. Philip Contzen, U. S. Deputy Surveyor, who had re-established the east boundary of T. 5 S., R. 16 E. I was enabled to find the corner of Tps. 4 & 5 S., Rgs. 16 & 17 E., which corner was within two miles of the Concord Lode. I therefore connected Corner No. 1 of the Concord Lode with the said township corner. As Corner No. 1 of the Concord Lode is not the corner nearest this township corner, I also connected Corner No. 4 of the Concord Lode to the said township corner.

From Corner No. 1 of the Concord Lode  
Cor. of Tps. 4 & 5 S., Rgs. 16 & 17 E. bears  $S. 83^{\circ} - \frac{6'}{4}$  E.,  
2171.5 feet distant.

From Corner No. 4 of the same lode  
the said township corner bears  $S. 77^{\circ} - 22' E.$ , 2451.6' dist.

Amended Notice of Mining Location.

The Saddle Mountain Mining Company, the undersigned, being the present owner of the concerned mining claim, which was located by George E. Chittenden on the 17th day of March 1893, and of which the location notice is recorded in the office of the Recorder of Mineral County, in Book 17 of Mines, at page 413, does hereby without waiver of any rights under said location, amend said location and said location notice, so that it shall read as follows:

To All The World by Congress:-

This notice of the discovery of valuable mineral deposits in the concerned mining claim, situated on lands belonging to the United States of America, and in which there are valuable mineral deposits, was first lawfully and lawfully located for the purpose of exploration and purchase by The Saddle Mountain Mining Company, by George E. Chittenden, manager, the undersigned, on the 4 day of Sept., A. D. 1893.

The length of said claim is 1500 feet, and its width is 500 feet in an Easterly direction of --- feet in a Westerly direction from the center of the discovery shaft, at which this notice is posted, lengthwise of the claim, together with 500 feet in width of the surface grounds on each side of the center of the claim. The general course of the lode, deposit and vein is from the East to the West.


