#### ADJOINING CLAIMS

This survey is bounded on the northwest by the Last Chance Lode Sur. No. 3085, John C. Gillespie and Dan Walsh, claimants.

There are no other adjoining claims.

#### INSTRUMENT .

This survey was made with a Lietz Light Mountain transit-theodolite, No. 13-5929. The courses were deflected from the true meridian, as determined by observations by the use of the Saegmuller Solar attachment. The distances were measured with a 100 foot and 300 foot steel tapes.

#### REPORT

Waste dump of one of the shafts of the Congress Consolidated Gold Mines Co. This was determined from the calls in the official records of the adjoing claims which were/to this monument.

The 1/4 cor. between sections 25-24, is a mound of stone as described in % the field notes for same, but I was unable to distinguish positively any markings on stones near by, as called for in the notes. This corner bears N.89°-55'E. 5286.4 ft. from the west 1/4 corner of section 23, so it agrees as exactly with the call for its true position according to the official records of subdivision of public lands.

Owing to the flatness of the veins passing through the above claims, topographical conditions have a great tendancy to cause the outcropping to have a zigzag and irregular course. This is very apparent on the Bull Dog Lode, where the vein passes through the west center end, and on ascending the mountain, has a southeasterly course to the discovery monument, which is located on the saddle of the range. As the ground slopes to the northeast from the saddle, this has a tendancy to swing the outcropping of the vein to the north from the initial course. Thus the center line of the claim is caused to swing at the discovery, and take a course toward the discovery on the Omaha Lode, which is directly in line with the east center end of the Bull-Dog lode.

The discrepancies found existing between the claims as marked by location monuments and as described in the location notices, are due to errors in the location notices.

#### ADDITIONAL REPORT

I was unable to find corners north and south, one half mile from the 1/4 corner between sections 23-24, T.10 N.R.6 W. and I assumed the course of said section line to be asofrecord. so could not comply with section 15 page 11 of the Manual.

Improvement No.4, a tunnel, was run on a vein outgropping on the Omaha lode, being the same vein which passes through improvements No. 2 and 3. As the apex of this vein is on the Omaha Lode and the tunnel starts within its boundaries, I believe that the same is conclusive evidence of its developing the Omaha lode, and its value properly included in the estimate of expenditures for this claim.
