Instrument and Determination of Meridian.

This survey was made with a Berger Engineer's Transit.

The courses were deflected from the true meridian as determined by direct Solar observation, verified by Polaris observation. The distances were measured with a 650 ft. steel tape.

Report.

The side and end lines of the claims in this survey and all tie lines were run direct upon the ground.

Corners of the public survey to which ties are given:

The west quarter corner of Section 19 as originally

set was a quartzite stone, 4 x 5 x 9 ins. out of the ground, with mound of stone along side, chiseled $\frac{1}{4}$ on the west face. This corner has recently been removed during the construction of the railroad from Inspiration Consolidated Copper Company's mine to their smelter and reset since the completion of the road, the point now being a nail driven in the planking of track scales, surrounded by five other nails, by the side of which is scribed W 1/4 19. I verify the location of this corner by retracing the tie from Cors. 1 of the Legal Tender and Brownie lodes of Sur. 3015, and the tie from Cor. 1 Yankey Jumper lode, Sur. 2923, and find it to be in its original position.

The N.W.Corner of Section 19 is not in. I establish the theoretical position of this corner north 2640 feet from the west quarter corner of said section.
