SOUTH BOUNDARY OF T. 1-South, R. 14-East.

Survey commenced August 14, 1906, and executed with a Young & Sons, light mountain transit, with Smith solar attachment No. 5609. The horizontal limb is provided with two double verniers placed opposite to each other, and reading to single minutes of arc, which is also the least count of the verniers of the latitude and declination arcs. The instrument was examined, tested on the true meridian at Phoenix, Arizona, found correct, and was approved by the Surveyor General for Arizona, August 8, 1906. I examine the adjustment of the transit and correct the level and collimation errors; then, to test the solar apparatus, by comparing its indications, resulting from solar observations made during a.m. and p.m., hours, with a meridian determined by observations on Polaris, I proceed as follows:-

At the cor. of Tps. 1 and 2 South, Ranges 13 and 14 East, latitude  $33^{\circ} 17' 28''$  N., longitude  $110^{\circ} 57' 20''$  W., I set off  $33^{\circ} 17'$  N., on the lat. arc and  $14^{\circ} 27'$  N. on the decl. arc and at 4 h p.m., l.m.t., determine with the solar a meridian and mark a point thereof, on a stone firmly set in the ground, 5 chs. N. of the cor.

August 14, 1906.

August 14: At 10 hrs. 00 m., a.m., l.m.t., by my watch, which is correct, I observe Polaris at eastern elongation in accordance with the Manual of Instructions, and mark a point on the line thus determined, on a peg driven in the ground, 5 chs. N. of my station. Aug. 15. 1906.

At 6 h., a.m., l.m.t., I lay off the azimuth of Polaris,  $1^{\circ} 26'$  to the East, and mark the meridian thus determined, by cutting a small groove in the stone set August 14, 1906, on which the meridian falls 0.4 ins. east of the mark determined by the solar.

At 7 h., a.m., l.m.t., I set off  $33^{\circ} 17'$  N. on the latitude arc and  $14^{\circ} 16'$  N. on the decl. arc; and mark a point in the meridian determined with the solar, by a cross on the stone already set 5 chs. N. of my station; this mark falls .2 ins. east of the meridian established by the Polaris observation.

The solar apparatus, by p.m. and a.m. observations, defines positions for meridians, respectively about  $0^{\circ} 21'$  west and  $0^{\circ} 10'$  east of the meridian established by the Polaris observations; therefore, I conclude that the adjustments of the instrument are satisfactory. The magnetic bearing of the true meridian at 7h 30 m., a.m. is N.  $13^{\circ} 45'$  W., the angle thus determined gives the mag. decl. at  $13^{\circ} 45'$  E.

Having ascertained that the measurements along the south line grant sufficient, therefore, for the purpose required giving surveyor, Gentry, it is proper width, I proceed to survey the south boundary first. At the S.W. cor., on which is a granite boulder, marked and with red paint, descends a thin scattering cedar timber and oak brush.
