Survey commenced March 26, 1911, and executed with a Buff & Burger engineer's transit #672 with solar attachment. The horizontal limb is provided with two double verniers placed opposite to each other, reading to 30" of arc. I examine the adjustments of the tranto 30" of arc. I examine the adjustments of the transit and solar apparatus, and find them to be correct; then, to test the solar apparatus, by comparing its indications, resulting from solar observations made during a.m. and p.m. hours, with a meridian determined by observations on Polaris, I proceed as follows:

At the Standard cor. of secs.35 and 36, at 7h.10m.p.m., 1.m.t., I observe Polaris at western elongation, in accordance with the Manual of Instructions, and mark a point in the line thus determined on a stake set

a point in the line thus determined, on a stake set in the ground about 5 chs. N.of my station.

March 26, 1911.

March 27. At 7:30 a.m., l.m.t., I lay off the azimuth of Polaris 1° 26' to the east, and mark the meridian thus determined, by a tack set in a stake about 5 chs. north of my station.

At 8:00 a.m., 1.m.t., I set off 35°10'N. on the lat.arc; 2021'N. on the decl.arc, and determine a meridian with the solar; this point falls 0.2 ins.east of the point

established by the Polaris observation.

At 12h.06m. p.m., 1.m.t., I set off 2°24'N.on the decl.

arc, and observe the sun on the meridian; the resulting lat. is 35° 10'N.

At 3h.0m. p.m., 1.m.t., I set off 35°10'N. on the lat.

arc; 2°27'N. on the decl.arc, and determine a meridian with the solar; this point falls 0.3 ins.east of the point established by the Polaris observation: I point established by the Polaris observation; I therefore conclude that the adjustments of my instru-

ment are satisfactory.

The magnetic bearing of the meridian is 14°50'W.; the angle thus determined gives the magnetic declination 14°50'E.: thence I run,

GENERAL DESCRIPTION.

This township contains land that is both extremely mountainous and gently rolling. The southern tier of sections lies on the north slope of the Hualpai Mountains, which are very difficult of access, and are of little value except for the mineral contained therein, there being numerous mining claims which are at present being developed, and show considerable value in gold, silver and lead. On the SW. 1 of sec.26 is the ranch house of W.E.Frost. On this section are located several small springs of pure water.

The gulch in the SW. $\frac{1}{4}$ of sec.36 contains a small running stream of pure water, which sinks before it leaves the

section.

On the NW. do sec. 28 is the ranch house of George W. Davis, near which is a spring of clear, pure water. The north half of the township is a rolling prairie, sloping to the north, and contains no water. The soil is a sandy loam mixed with gravel, with a hard clay sub-soil; this land produces an excellent growth of bunch grass, the few cattle were seen grazing on the township.
