This township is in general, broken and heavily rolling land, draining from the East and West into Camp Grant wash. There is no living water in the Tp. The only settlement noted is the ranch of Wills and Kellogg, in SE. ‡ of sec. 16, better known as the "snyder Ranch", consisting of frame house, good well, windmill, also pumping plant, corrals, etc., water being found at this point at a depth of 125 ft.

A small drain of water has been developed also by driving a tunnel for about 100 ft. into the granite cliff, near Camp Grant wash, in SE. ‡ of sec. 3.

There is no timber in the Tp, nor any indi-

There is no timber in the Tp, nor any indications of mineral, The rock formation is mostly granite base, overlaid with conglomerate with outcroppings of shale and gneiss in the deeper canyons in NE. portion of the Tp.

Some good agricultural land lies along the narrow valley of Camp Grant wash, but the land is in general suitable only for grazing purposes.

A considerable stream of running water shows up in Camp Grant wash about 10 chs. N. of the N. bdy. of the Tp. The wash below the water however, narrows into a canyon leading into the San Pedro River.
