Retracement of part of Subdivision lines of frac. T. 8 S. R. 32

Chains.

Retracement commenced May 4, 1914, and executed with a Young and Sons light mountain transit No.8541, with Smith solar attachment. For description of this instrument, and Certificate of Approval, see Book "A.

I examine the adjustments of the transit, and find it correct; then, to test the solar apparatus by comparing its indications resulting from solar observations made during a.m. and p.m. hours, with a meridian determined by observations on Polaris, I proceed as follows:

At camp hear the center of the SE-1 of sec.8, of frac.T. 8 S., R.32 E.; latitude, 32° 44½' N.; longitude, 109° 5'W., I set off 32° 44½'N. on the lat.arc; 15°58½'N. on the declearc, and at 5h.p.m., l.m..t., determine with the solar a meridian, and mark a point thereon by setting a flag firmly in the ground, about 6 chs. north of my station.

At 9h. 43m. p.m., by my watch, which is correct l.m.t., I observe Polaris in accordance with Manual of Instructions, and mark a point in the line thus determined, on a peg driven in the ground, about 6 chs. north of the same station.

May 4, 1914.

may 5, 1914: At 6h. 30m., a.m., l.m.t., I lay off the azimuth of Polaris 0°20' to the east, which is the azimuth corresponding to an hour angle of 0h.57m., the point falling on flag set by solar observation yesterday.

At 6h. 33m. a.m., l.m.t., I set off 32°44½'N. on the lat.

arc; 16°8½'N. on the decl.arc; and determine with

the solar a meridian, which agrees with the p.m. observation of May 4, 1914; therefore, I conclude that the adjustments of the instrument are satisfactory.

The magnetic decl. of the true meridian, at 6h.30m.asm.,
is 13°10 E.

I test the stadia wire interval by setting rod 801.6 1ks. from my station; the rod reading is 4.000 ft., which is correct.

At 8h. a.m., 1.m.t., I set off 32° 43½ N. on the lat.arc; 16°8½ N. on the decl.arc; and determine a meridian with the solar at the original ½ sec.cor. bet; secs. 17 and 20, which is a stone 6x8x8 ins. protruding from a mound of stone, marked 1 on the N.face.
