

Gentlemen:

Recently our firm was engaged in a survey of a portion of the East 1/2 of Section 29 and the West 1/2 of Section 28, Township 6 North, Range 4 East, of the Gila and Salt River Base and Meridian, Maricopa County, Arizona.

We obtained through your office a copy of the original survey notes for the subdivision of the above mentioned Township, shown as Book "G", Contract Number 162, dated January 5, 1910; and recorded as Book 2787.

During the course of our survey field work we found two porphyry stones lying loose on the ground, and in close proximity evidence of two rock cairns which had been disturbed by campers to be used as fire pits. We were able to determine by use of the original field notes, that the one stone was in fact the 1/4 corner between said Sections 28 and 29, and the other stone was the South 1/4 corner of said Section 29. This fact was ascertained by locating the bearing trees as called out in the original field notes.

On May 30, 1979, under my direction, and using the original field notes to duplicate the location of said Stones, a 2" diameter crown head brass cap was driven affixed into a 4' long galvanized steel pipe, placed in the ground at natural ground elevation, and reinforced with placed concrete. The brass caps were stamped respectively; E 1/4 29 E 1/4 28 and S 1/4 29 N 1/4 32, thereby perpetuating the original corners as established in the original survey.

GENERAL DESCRIPTION.

Township 6 North, Range 4 East, is extremely mountainous, rocky and rough in the northern portion, having very steep slopes. The ground is very much broken and shattered. Geologically, slate, schist, granite and lime predominating, with occasional malapai and other forms of porphyry, intimately intermingled, and in most cases standing on edge, or at a very steep dip.

Gold bearing quartz and float is very frequent, and

Gold bearing quartz and float is very frequent, and surface indications of mineral are very good, but the country has the appearance of being too greatly shattered and disturbed locally to expect any permanent ore denosits.

The northern portion is well watered, containing sev-

eral springs.

The undergrowth is catclaw, scrub mesquite and palo verde, giant cactus, cholla, ocotillo, Spanish bayonet, with scrub oak on the northern slopes of the higher peaks

The eastern, western and southern boundaries, and for a mile on each side, are mountainous and broken, similar to the northern portion, but not to such an extreme degree.

Black mountain on the southern boundary is a big extrusion of a coarse grained, highly eroded, orthoclase granite, which upturned the area of slate lying on the west, forming the western portion of the mountain. The Mormon Girl mine is located in the slate on the south spur of this mountain.

The interior portion of the township is mountainous and rolling, is cut by deep washes, arroyos and canyons, which drain to Cave Creek from both sides.

The soil, in very small areas, in some of the washes,

The soil, in very small areas, in some of the washes, is a rich, sandy, loam, capable of high cultivation under irrigation.

The rolling mesas and ridges are granite base and gravel and adobe clay, or slate gravel and pebbles on top.

The undergrowth is very dense in places. A second growth of scrub palo verde, palo cristo, mesquite, catclaw, greasewood and several varities of cactus.
