Work executed gointly son dates shown on diagram on page 39 of this book, by U.S. Surveyors Ralph Gentry and Hargraves Wood, using Buff and Buff transits Nos. 8028 and 9223 respectively. Both instruments are equipped with solar attachments. The horizontal limbs are provided with two double verniers placed opposite to each other, reading to single minutes of arc; which is also the least count of the verniers of the latitude and declination arcs. Instruments were approved by the Assistant Supervisor of Surveys, District No. 5, subject to satisfactory field tests, a record of which follows herein, on Feb. 1st, 1916.

### Field tests of Solar Transits.

Feb. 13, 1916.

Both instruments were set up at camp, near the \(\frac{1}{4}\) sec. corbet. secs. 16 and 21, in T. 19 S., R. 22 E., lat. 31°46' N., long. 110°06'W., the level and collimation adjustments examined, and errors corrected. Then, at 4h 00m, p.m., l.m.t., we set off 31°46' on the lat. arcs, and 13°30'S. on the decl. arcs, and determine meridians with the solars; marking points in the same by tacks driven in Wooden stakes firmly set in the ground 5 chs. N. of in wooden stakes firmly set in the ground 5 chs. N. of our stations.

At 9h 55m, p.m., l.m.t., we observe Polaris at western elongation, in accordance with instructions in the Manual, and mark points in the lines thus determined by tacks driven in wooden stakes firmly set in the ground W. of the points set by the solars.

Feb. 14, 1916.

At 7h 50m, a.m., we turn off the azimuth of Polaris
1°20' to the E., and mark the meridian thus determined
by a tack driven in a wooden stake along side of these set by the solars.

At 8h 00m, a.m., l.m.t., we set off 31°46' on the lat. arcs, and 13°17's. on the decl. arcs. and determine meridians with the solars.

The a.m. and p.m. solar observations above described with both instruments, agree within less than one minute of arc with the meridians established by the Polaris observations. It is therefore concluded that the adjustments are satisfactory.

The magnetic bearing of the true meridian, at 8h 00m, a.m. is N.13°30'W. The angle thus determined gives for the magnetic declination, 13°30E.
