#### GERERAL DESCRIPTION.

The eastern range of sections in this township is rough and mountainous, the second range lies in the foothills and the balance of the township is rolling prairie. The general drainage is to the west.

The soil in the first and second ranges of sections, on the east, is rocky and of the poorest quality; while that in the western part is slightly better, being about 3rd rate.

The mountainous land is covered with a growth of scrub oak, cedar, piñon, manzanita, catclaw, cactus and buckbrush. The vegetation on the prairie land consists of cactus, catclaw, greasewood, spanish-bayonet, sage-brush, and a good growth of grass, suitable for grazing. There is no timber.

Water exists at Quail Springs, in the SE. quarter of section 2. No evidences of mineral were apparent, though some prospecting has been done.

The road from White Hills to Chloride enters the township in the west part of section 5 and leaves it in the west part of section 36, Chloride being some three miles south east.

There are no settlers.
