Resurveys and csurveys hereinafter described, executed by #1.W. Chapin, Unsiburveyor, on dates showneon diagram and page 1 hereof, using 1 Young land n Some transit 50.8487. The mastrument is equipped with a full vertical circle, and the Smith solar attachment.

I examine the adjustments of the instrument and correct

I examine the adjustments of the instrument and correct all errors, then to test the solar apparatus by comparing its indications resulting from solar observations made during a.m. and p.m. hours with a meridian established by Polaris observation proceed as follows:

- November 27,1921.

 In camp near the ½ sec. cor. of secs. 3 and 4 ,T.13 S., R.18 E., Gila and Salt River Base and Meridian, Arizona in latitude 32°21'N. and longitude 110°29'W. of Greenwich at 9h 00m a.m. app. t., set off 32°21' on the lat. arc, 21°5½'S. on the declination arc and determine a meridian with the solar and measure the deflection angle to a reference mark N.29°00'E. about 30 chs. dist.
- At app.noon with the latitude arc unchanged, observe the sun on the meridian, the resulting reading of the declination arc is 210721 Swhichagrees with the computed declination of the sun.
- At 3h 00m p.m.app.t., with the latitude arc unchanged set off 21°8'S. on the declination arc and determine a meridian with the solar, which agrees within 1° of the meridian established with the solar at 9 a.m.
- As all of the solar observations during the usual hours of solar work come within 1'30" of the true meridian, conclude that the adjustments of the instrument are satisfactory.
- Unless otherwise specified all measurements are made with a 5 chain Lufkin steel tape compared with a standard steel tape and found correct. The measurements are made on the slope, the vertical angles obtained and the slope measurements properly reduced to true horizontal distances.

Direct solar observations were taken at frequent intervals when in the field on line, and most of the azimuth determinations were obtained from these direct observations and the lines projected by fore and back sight. On account of the open nature of the country this method appeared more accurate and practicable than to use the solar. The final direct observation is given in Book "C".

Resurvey of part of the North bdy. of Township 12 South, Range 18 East

Chains.

The east 32 miles of the North boundary of T.12 S., R.18 E., was surveyed by John L. Harris, U.S.D.S. in 1879. No resurvey or retracement of any part of this line is of record.

The following notes describe a resurvey of that portion of the line between the east halves of secs. 4 and 33.

Retracement for Resurvey.

The original cor.monument of secs. 2, 3, 34 and 35 has disappeared, and the original bearing tree also has been washed away. The true point of original location of this section cor. falls in the middle of a wash 30 lks.wide and 10 ft.deep; course W. This point is determined by testimony and direction of old settlers in the vicinity who had seen the original cor. monument and its bearing tree before the destruction of same. At 65 lks. N. of true point, set an iron post, 3 ft.long, 2 ins.in diam., 30 ins. in the ground for witness cor. to the reestablished cor. of secs. 2,3,34 and 35, marked on brass cap,

GENERAL DESCRIPTION

The surface of the portion of T.12 S., R.18 E., surveyed under this assignment is rolling broken and mountainous. The elevation ranges from about 3000 ft. in sec. 4 to about 4700 ft. in sec. 31.

There is very little timber of any kind. On the higher portions is some scattering mesquite and palo verde. A few sycamore, willow and alder are found along Buehman Canyon.

The undergrowth is principally greasewood, ocetillo, spanish dagger and catclaw. There is a fair growth of grass.

Buehman Canyon contains an intermitent stremm of

water, which is the only water in the township.

No indication of valuable mineral deposits were found. C.C. Parker has a homestead in sec. 7.
