- Surveys and resurveys here inafter described executed by William H. Thorn, U.S. Cadastral Engineer, and Benjamin J. Kinsey, U.S. Transitman, on dates shown on diagram on page 1 hereof, using respectively Young and Sons light mountain transits Nos. 8592 and 8487. Each transit is equipped with full vertical circles and the Smith solar attachment. Unless otherwise specified, all azimuth determinations are accomplished with the solar attachment.
- we examine the adjustment of the transits and correct all errors; them, to test the solar apparatus, by comparing its indications, resulting from solar observations made during a.m. and p.m. hours with a meridian determined by Polaris observations, we proceed with each instrument as follows:
- March 5, 1921. At camp, near the 1 sec. cor. of secs. 17 and 18, T.5 S..R.31 E., Gila and Salt River Base and Meridian, Arizona, in latitude 32°59½'N.; longitude, 109° 10½'W., at 8h.35.5m. p.m., 1.m. t., observe Polaris at Western elongation, making four observations, two each with the telescope in direct and reversed positions, and mark the mean point in the line thus determined by a nail in a stake firmly driven in the ground, 5 chs. N.
- Azimuth of Polaris at Western elongation' = 1º19'38".
- March 6, 1921: At 8h.0m. a.m., 1.m.t., set off the azimuth of Polaris, 1°19½ to the east, and mark the meridian thus determined by an iron pin, firmly driven in the ground, 5 chs. N.
- At 9h. 0m.,a.m., 1.m.t., set off 32°59½'N.on the lat.arc; 5°40½'S. on the decl.arc, and determine a meridian with the solar, which agrees with the true meridian.
- At apparent noon, with the lat.arc unchanged, observe the sun on the meridian; the resulting reading of the decl.arc is 5°37½'S., which agrees with the computed decl. of the sun,
- At 3h. 0m.p.m., l.m.t., with the lat.arc unchanged, set off 5°34½'S. on the decl.arc, and determine a meridian with the solar, which agrees with the true meridian.
- As all of the solar observations made during the usual hours of solar work come within 1'30" of the true meridian, we conclude that the adjustment of the transits is satisfactory.
- Unless otherwise specified, all measurements are made with a Lufkin steel tape, 5 chs. in length, compared with a Chesterman standard steel tape, and found correct. The measurements are made on the slope, the vertical angles determined with clinometers, and the slope measurements properly reduced to true horizontal distances.

GENERAL DESCRIPTION.

This township is situated in Greenlee County, Arizona, about three miles west from the East bdy.of the state, and about 6 miles southeast from Clifton, the county seat. Most of the surface is mountainous, being on the southwest slope of Big Lue Mountain. On a number of the mesas and benches, the land is level, nearly level or gently rolling. The soil is rocky, 3rd and 4th rate, except in the SW. quarter, where part has a gravelly adobe, 2nd rate. There is no timber, except a fringe of scattering cotton-wood, sycamore, mesquite, oak and walnut along some of the larger washes in the canyons. There are no permanent streams of running water, the water courses being dry washes, gulches and drawsdraining SW. into the Gila River.
A fair growth of grass is prevalent in all sections.
There is no evidence of valuable mineral deposits. There are several permanent springs, one in sec. 5, one in sec. 8, one in sec. 14 and one in sec. 36. Near the east boundary, just outside the township, east of secs.
12 and 25, are several springs, and in sec.15 in Lop
Ear Creek, there is water in pools.
There are several settlers, G.Stockton in sec.4, Frank Davis in sec., Frank Stockton in sec. 10, Lop Mar Davis in sec. 14, J. Fulcher in sec. 17, and Mrs. J. G. Smith in sec.25. Besides the houses, corrals, wells, and other improvements belonging to these settlers, the improvements in the township consist of several range fences extending for considerable distances, and a telephone line NW: and SE., thru. sec.31. Roads extend SW. from the Fulcher ranch, from the Frank Stockton ranch, and Mrs.J.G. Smith's ranch, extending southwesterly to Guthrie and Northwesterly to Clifton. The township is now utilized entirely for grazing, which

is probably the only purpose for which it is suitable.
