- Surveys herein described, were executed on dates shown on diagram on page 1 hereof, by Dupree R. iverill & William E. Hiester U. S. surveyors, using Buff and Buff light mountain transits Nos. 10125 and 9977. Each instrument is equipped with a full vertical circle and the Smith solar attachment. Unless otherwise specified all azimuth determinations are accomplished with the solar attachments.
- January 9, 1922: We examine the adjustments of the instruments and correct all errors; then to test the solar apparatus by comparing their indications, resulting from solar observations made during a.m. and p.m. hours with a meridian established from observation on Polaris proceed as follows?
- Jan. 10: At our camp in the NW. quarter of sec. 7, 7.32
 N.,R.11 W., Gl& S.R.B.& M., in latitude 36°11½N.,longitude 113°3½%W., at Ohrs. 14 m., a.m.l.m.t., we observe
 Polaris at western elongation, making four observations
 two each with telescope in direct and reversed positions
 and mark the mean point in the line thus determined on
 a peg driven firmly in the ground 5 chs. N.
- Azimuth of Polaris at western elongation = 10222199
- At 8hrs. Om a.m., l.m.t. we lay off the azimuth of Polaris 1°22½ to the east, and mark the meridian thus determined by a tack in a stake driven firmly in the ground 5 chs. N.
- At 9hrs. Om a.m., l.m.t., we set off 36°ll. on the latitude arcs, 21°58's. on the declination arcs, and determine a meridian with each solar, which we find to agree with the true meridian.
- At apparent noon with the latitude arcs unchanged, we observe the sun on the meridian with each solar, the resulting readings of the declination arcs are 21°57½. Which agrees with the computed declination of the sun.
- At 3hrs. Om. p.m., l.m.t., with the latitude arcs.unchanged we set off 21956'S. on the declination arcs and determine a meridian with each solar, which we find to agree with the true meridian.
- As all of the solar observations made during the usual hours of solar work come within 1 of the true meridian we conclude that the adjustments of the instruments are satisfactory.
- Feb. 1, 1922: Instrument No. 10125, tested on meridian described above hourly throughout the day by William E. Hiester and found to be satisfactory.
- Feb. 13, 1922: Instrument No. 9977, tested on meridian described above hourly throughout the day by Dupree R. Averill and found to be satisfactory.
- The measurements are made with Lufkin steel tapes, 5 chs in length, compared with a Lufkin standard steel tape and found correct. The measurements are made on the slope, the slope angles determined with clinometers, and the slope distances reduced to the horizontal equivelent for entry in the field notes.

GENERAL DESCRIPTION.

This township contains nearly every variety of surface from level to mountain ous. The NE.half is mainly mountainous, draining into Dansil Canyon, which heads in the northwestern quarter of the township, and passes with an easterly course thru. the north two tiers of sections. The bottom of this canyon is joined near the E. boundaries of secs.1 and 12 by the bottom of Andrus Canyon, which passes with a southeasterly course thru.sec.1.

The SW.half is mainly rolling and gently rolling, draining southwesterly from a rim which extends RW. from the S. bdy. of sec. 36 into the NW. quarter of the township. Secs. 6,7, and 18 drain northerly into the head of Penn Valley in sec.6, where there is some level and nearly level surface. In sed. 31, there is also some level and nearly level surface in the head of Horse Valley.

The soil is rocky, 3rd and 4th rate, with the exception of parts of secs.6 and situated in the Penn and Horse Valleys, where there is a sandy and gravelly clay loam, 1st and 2nd rate.

The timber, consisting of cedar, pinyon and yellow pine is dense over the entire township, except the northeastern quarter, where it is mainly scattering.

The undergrowth, concisting of sagebrush, black brush, scrub oak, dogwood, catclaw. Spanish bayonet and cactus is scattering over most of the area, but there are dense growths in several sections.

There are no water courses carrying a permanent flow of water.

Dansill Spring in sec.10, a spring in sec.2, and a well in sec.7 constitute the water supply of the township.

There are no indications of valuable mineral deposits.

Two settlers are located within the township, J.D. Waring in sec. 7, with improvements consisting of house, well, corral and fences, and Wiggins, in with house in sec. 29.

A drift fence extends from the rim in sec. 26 southwesterly into the SW. 2 of sec.34; thence southeasterly into T.31 N., R.11 W.

A road following the bottom of Andrus Sanyon in sec.1, another bearing northerly and southerly thrused. 7 and parts of secs. 6 and 18 near W. bdy. of Tp., and another bearing northwesterly and southeasterly thru. the $\sqrt[3]{2}$ of sec. 31. and a trail bearing easterly and westerly thru the N. 2 of the Tp., constitute the only means of travel.
