Retracements, resurveys and surveys herein described were executed on dates shown on diagram of page 1-a hereof, by Dupree R. Averill, U.S.S.; and Roger F. Wilson, U. S. T., using respectively Young and Sons light mountain transit No. 8540 and Buff and Buff light mountain transit No. 9221, each equipped with full vertical circle and Smith solar attachment. Unless otherwise specified all azimuth determinations are accomplished with the solar attachment.

Polaris observation and field test by Roger F. Wilson, using instrument No. 9221

January 2, 1924: I examine the adjustments of the taransit and correct all errors, then to test the solar apparatus by comparing its indications resulting from observations made during a.m., and p.m., hours with a meridian established by Polaris observation, I proceed as follows:

January 3; 1924: At camp near the center of sec., 16 T.4 S., R.16 E., G. & S.R.B. & M., latitude 33° 05'N., longitude 110° 42' 30" W., at 00H. 46M. a.m., l.m.t., I observe Polaris at western elongation, making four observations with the telescope in direct and reverse positions, and mark the mean point in the line thus determined by a tack in a peg driven firmly in the ground 6.00 chs., N.,

Azimuth of Polaris at western elongation: 1°18'39".

At Sh. 90m., a.m., l.m.t., I lay off the azimuth of Polaris 1° 18½ " to the east and mark the meridian thus determined by a tack in a peg driven firmly in the ground 6 chs., N.,

At 9h.20m. a.m., l.m.t., I set off 33°05'N., on the latitude arc, 22°52'S., on the decl., arc, and determine a meridian with the solar apparatus. The solar meridian coincides with the true meridian previously determined.

At appt., noon, with the latitude are unchanged I observe the sun upon the meridian; the resulting reading on the decl., are is 22°52'S., which agrees with the computed declination of the sun.

At 3h.00m., p.m., l.m.t., with the lat., arc unchanged and a setting of 22° 50½CS. on the decl., arc., I determine a meridian with the solar. This determination agrees with the true meridian.

As all solar observations during the usual hours of solar work fall within 1' of the true meridian I conclude that the adjustments of the transit are satisfactory.

Field test by Dupree R. Averill, using transit No. 8540.

I examine the adjustments of the transit and correct all errors, then to test the solar apparatus by comparing its indications, resulting from observations made during a.m., and p.m., hours with a true meridian established by Polaris observation, I proceed as follows:

January 0, 1924: At camp in sec.16, T.4 S., R.16 E., upon the meridian previously established by Roger F. Wilson, W.S. Transitman, at 9h. 70m., a.m., 1.m.t., I set off 33°05'N. on the lat., arc, 22° 33½'S. on the decl., arc and determine a meridian with the

solar apparatus. This meridian coincides with the true meridian previously determined by Polaris observation.

At appt., noon, with the lat., are unchanged I observe the sun upon the meridian. The resulting declination is 22° 33; S., which agrees with the computed declination of the sun.

At 3h. 00m., pm. l.m.t., with the lat., arc unchanged and a reading of 22° 312'S., on the deel., arc I determine a meridian with the solar attachment. This meridian falls 30" to the east of the true meridian.

As all observations made during the usual hours of solar work agree well within 1' of arc of the true meridian I conclude that the adjustments of the transit are satisfactory.

Final tests of transits Nos. 9221 and 8540.

110°42'30'W., at 3h. 00m. p.m., l.m.t., I set off 33°05'N., jon the late, are 19°16'Sahon the declarare, and determine a meridian with the solar and mark the position of this line by a tack in a per driven firmly in the ground 5 chs., N., of my station.

At 5h. 23m., p.m., l.m.t., I observe Polaris at upper culmination, taking four observations with the telescope in direct and reversed positions, and note that the meridian thus determined coincides with the solar meridian previously established.

Jan., 25, 1924. At 8h. 00m., a.m., l.m.t., I set off 33° 05'N., on the latitude arc, 19° 07'S., on the decl arc, and observe that the solar meridian agrees with the true meridian determined by Polaris observation.

Unless otherwise specified all measurements are made with a Lallie steel tape, 5 chs., in length, first compared with a Lufkin 1 ch., standard steel tape and found correct. All measurements are made on the slope, the slope angles determined by transit or clinometer readings and the slope measurements properly reduced to their true horizontal equivalents.


