Resurveys and surveys, herein described, were executed on dates shown on diagram on page 1 hereof, by Benjamin J.Kinsey, U.S. Surveyor, using Buff and Buff light mountain transit No.9940, and Theodore Vander Meer, U.S.Transitman, using Young and Sons'light mountain transit No.8389, both equipped with full evertical circles and Smith solar attachments; unless otherwise specified, all azimuth determinations are accomplished with the solar attachment.

Test of Instrument No.9940.

Nov. 30, 1924: Examine the adjustments of the transit, and correct all errors; then, to test the solar apparatus by comparing its indications, resulting from observations made during a.m. and p.m. hours with a meridian established by Polaris observation. proceed as follows:

Dec.1, 1924: At camp near the sec.cor.of secs.23 and 24,T.1S.,R.

12 E.,G. and S.R.B. and M., Arizona: latitude, 33.19% N., longitude, 111.05% W., at 2h.53m.a.m., l.m.t., observe Polaris at western elongation, making four observations, two each with the telescope in direct and reversed positions, and mark the mean point in line thus determined on a paradainer firmly in the ground. line thus determined on a peg driven firmly in the ground, 5 chs.N.

Azimuth of Polaris at western elongation = 1°18'.

At 7h.45m.a.m., 1.m.t., lay off the azimuth of Polaris 1°18'to the E., and mark the meridian thus determined by a tack in a peg

driven firmly in the ground, 5 chs.N.

At 8h.0m.a.m., 1.m.t., set off 33°19½'N. on the lat.arc; 21°47'S. on the decl.arc, and determine a meridian with the solar, which agrees with the true meridian.

At apparent noon, with the lat.arc unchanged, observe the sun on the meridian; the resulting reading of the decl. arc is 21°50'S, which agrees with the computed decl. of the sun.

At 4h.0m. p.m., l.m.t., with the lat. arc unchanged, set off 21°50's. on the decl.arc, and determine a meridian with the solat, which agrees with the true meridian.

As all of the solar observations during the usual hours of solar work come within 1'30" of the true meridian, conclude that the adjustments of the instrument are satisfactory.

- Test of Instrument No. 8390, by Theodore Vander Meer, U.S. Transitman on above described meridian.
- Dec.6, 1924: Examine the adjustments of the transit and find them correct; then, to test the solar apparatus by comparing its indications, resulting from observations made during a.m. and p.m. hours with a meridian established by Polaris observation. proceed as follows:
- At 8h.0m. a.m., l.m.t., set off 33°19½'N. on the lat.arc; 22°27½'S. on the decl.arc, and determine a meridian with the solar, which agrees with the true meridian.

At apparent noon, with the lat.arc unchanged, observe the sun on the meridian; the resulting reading of the decl.arc is 22° 31'S., which agrees with the computed decl. of the sun.

- At 4h.p.m., l.m.t., with the lat. arc unchanged, set off 22°30'S. on the decl.arc, and determine a meridian with the solar, which agrees with the true meridian.
- As all of the solar observations during the usual hours of solar work come within 1'30" of the true meridian, conclude that the adjustments of the instrument are satisfactory.

Unless otherwise specified, all measurements aremade with Lufkin steel tapes 5 chs.in length, compared with a Lufkin 1 ch. standard steep tape, and found correct. The measurements are made on the slope, the vertical angles determined, and the slope measurements properly reduced to true horizontal distances for entry in the field notes.

The East bdy.of T.1 S., R.12 E., was surveyed by A.B. Titus U.S.D.S.in 1905, establishing thereon all 4 sec. and sec.monuments with a common reference to areas both sides of the line.

No retracement or resurvey of any part of this range line is of record.

The following notes describe a resurvey of the entire lime. As secs. 18 and 19 of T.1 S., R.13 E.are accepted surveyed areas, the resurvey of that portion of the line forming the West bdy.of said secs.is not subject to rectification in alignment, but in view of the fact that the land E. and W. of the remainder of the range line is unsurveyed, the resurvey of the North two miles, and the south two miles of this township bdy. is subject to rectification.

The continued satisfactory adjustment of the solar apparatus throughout the survey of this township is indicated from field test described in Book "C."

GENERAL DESCRIPTION.

Land in the southwest part of this township is rolling desert, and has the vegetation characteristic of Arizona land of that elevation, which is about 2500 feet. It has no water developed except that in sec. 28 at what is known as Happy Camp.

what is known as Happy Camp.

The remainder of the township, roughly the northeast twothirds, is more rugged; the east tier of sections is
extremely so. In section 36 are parts of the scenic
attractions, known as Apache Leap and Queen Creek Canyon.

The northeast portion has some of the undergrowth common to less arid regions such as oak brush, manzanita, mandogany, and chaparral. These are mainly on other than south slopes, where the vegetation of lower elevations is more likely.

The entire township has been deforested for fuel, but a moderate amount of young growth is again to be seen. Secs.l and 12 are in the southwest part of a region natural to mountain cypress, and its north slopes have a heavy growth of that timber. Other varieties of timber are scarce everywhere. Those seen occasionally are oak, juniper, cedar, pinyon, cottonwood and sycamore.

The soil is generally of a granite adobe of sufficient depth. Rock where exposed is usually granite. No igneous formations were observed. Mineral is very common, though only the more common metals have so far been found. A mine in sec. 35 is a large copper producer.

The amount of "range" to include both grass and edible undergrowth is varying. Sec. 31 appeared able to support no more than ten head of cattle, while sec. 1 hight feed fifty continuously.
