Survey commenced Dec. 19, 1924, and executed by William E. Hiester, U.S. Surveyor, and Willis W. Bandy, U.S. Surveyor, on dates shown on diagram on page 1 hereof, using respectively Buff light mountain transit No.9977 and Young and Sons transit No.85,13. Both instruments are equipped with full vertical circles and the Smith solar attachment, and were approved by the Assistant Supervisor of Surveys, conditional upon satisfactory field tests. Unless otherwise specified all azimuths determinations are accomplished with the solar attachments.

For test of Young and Sons transit No.8513 on Jan.26, see Book "B" of this Group.

Test of Buff Transit No.9977 by
William E. Hiester, U.S. Surveyor.

I examine the adjustments of the transit and correct all errors; then to test the solar apparatus by comparing its indications resulting from solar observations made during a.m. and p.m. hours with a meridian determined from observation on Polaris, proceed as follows:

Dec. 20, 1924: At camp, which is located in the NE. 4 of sec. 24, T.41 N., R.8 W., Gila and Salt River Base and Meridian, in latitude 36.56½ N., longitude 113.1 W. of Greenwich, at Ih 36.6m a.m. l.m.t., I observe Polaris at western elongation, making four observations, two each with the telescope in direct and reversed positions and mark the mean point in the line thus determined on a peg driven firmly in the ground 5 chs. N.

Azimuth of Polaris at Western Elongation =1.22 10".

At 7h 30 m a.m., l.m.t., I lay off the azimuth of Polaris 1°22' to the east and mark the meridian thus determined by a tack in a stake driven firmly in the ground 5 chs.

At 8h 0m a.m., app.t., I set off 36°56 N. on the latitude arc., 23°21 S. on the declination are and determine a meridian with the solar which agrees within 1' of the true meridian.

At app. noon with the latitude arc unchanged, I observe the sun on the meridian, the resulting reading of the declination arc is 23°25'S., which agrees with the computed declination of the sun.

At 4h 0m p.m., app.t., with the latitude are unchanged, I set off 23°212'S, on the declination are and determine a meridian with the solar which agrees with the true meridian.

As all of the solar observations taken during the usual hours of solar work come within 1 of the true meridian I conclude that the adjustments of the instrument are satisfactory.

The instruments were tested at frequent intervals and maintained in satisfactory adjustment throughout the survey. For final test of solars upon completion of the township, see Book "C".

Unless otherwise specified, all measurements are determined with Lufkin 5 ch. steel tapes, compared with a Lufkin standard steel tape and found correct. The measurements are made on the slope, the slope angles determined with clinometers and the slope measurements reduced to the true horizontal equivelent for entry in the field notes.

GENERAL DESCRIPTION
