- Survey commenced Feb. 8, 1925, and executed by William E. Hiester, U.S.Surveyor, and Willis W. Bandy, U.S. Surveyor, on dates shown on diagram on page 1, hereof, using respectively, Young and Sons transit No. 8534 and Young and Sons transit No. 8513. Both instruments and equipped with full vertical circles and Smith solar attachments, and were approved by the Assistant Supervisor of Surveys, conditional upon satisfactory field tests, Unless otherwise specified all azimuth determinations are accomplished with the solar attachments.
- We examine the adjustments of the transits and correct all errors; then to test the solar apparatus by comparing their indications resulting from solar observations made during a.m. and p.m. hours, with a meridian determined from observation on Polaris, proceed as follows:
- Feb. 8, 1925: At camp which is located in the SN. 2 of sec. 17, T.41 N., R.5 W., Gila and Salt River Base and Meridian, in latitude 36°57'N., longitude 112°52'W., of Greewich, 10h 16m p.m., 1.m.t., we observe Polaris at western elongation, making four observations, two each with telescope in direct and reversed positions and mark the mean point in the line thus determined on a peg driven firmly in the ground 5 chs. N.
- Azimuth of Polaris at western elongation = 1°22'5".
- Feb. 9, 1925: At 8h Om a.m., l.m.t., we lay off the azimuth of Polaris 1°22' to the east and mark a point in the meridian on a peg driven firmly in the ground 5 chs. N.
- At 8h 0m a.m., app.t., we set off 36°57'N., on the latitude arc and 14°39'S., on the declination arc of each instrument and determine meridians with the solars which fall within 1' of the true meridian.
- At app. noon with the latitude arcs unchanged, we observe the sun on the meridian, the resulting readings of the declination arcs are 14°37½ S., which agrees with the computed declination of the sun.
- At 4h Om p.m., app.t., with the latitude arcs unchanged, we set off 14°32½'S. on the declination arcs and determine meridians with the solars which agree with the true meridian.
- As all of the solar observations taken during the usual hours of solar work define meridians which fall within 1½' of the true meridian we conclude that the adjustments of the instruments are satisfactory.
- The instruments were tested at frequent intervals and maintained in satisfactory adjustment throughout the survey. For test of solars on Feb. 22, at conclusion of the survey of this township, see Book "D".
- Unless otherwise specified, all measurements are determined with Lufkin 5-chain steel tapes, compared with a Lufkin standard steel tape and found correct. The measurements are made on the slope, the slope angles determined with clinometers and the slope measurements reduced to true horizontal distances for entry in the field notes.
- Note: Buff transit No.9977, used by William E. Hiester in the survey of T.41 N., R.9 W. was also tested on above meridian, and found correct.
