Surveys herein described were executed on dates shown on diagram on page 1 hereof, by John L. Warboys, U. S. Surveyor, using Young and Sons transit No. 8385, with Smith solar attachment and full vertical circle. The horizontal limb is provided with two double verniers placed opposite each other, reading to single minutes of arc, which is also the least count of the verniers of the latitude and declination arcs.

The instrument was approved, subject to the usual field tests, by the District Cadastral Engineer for Arizona. For establishment of meridian at camp, near the center of SW1/4 of sec. 13, T. 5 N., R. 23 E.,G. S.R. B. M., Ariz., lat. 339 50 N., longitude (approximate) 109° 52 ½! W., on October 8, 1929, see Book "A".

For preliminary test, on the above meridian, on November 3, 1929, see Book "A".

All refraction corrections used are 83% of the tabular values on account of the elevation of 5600 ft. above sea level.

November 24, 1929: on the meridian, above mentioned, at 8h 00m a.m., app.t., set off 33° 50' N.' on the lat. arc, 20° 30' S. on the decl. arc and determine a meridian with the solar, which is found to agree with the true meridian.

At app. noon, with the lat. arc unchanged, observe the sun on the meridian, the resulting reading of the declare is 20° 33½ S., which agrees with the computed decl. of the sun.

At 4h 00m p.m., app.t., with the lat. arc unchanged, set off 20° 34'S. on the decl. arc and determine a meridian with the solar, which is found to agree with the true meridian.

As all of the solar observations during the usual hours of solar work come within l'of the true meridian, conclude that the adjustments of the instrument have

been satisfactorily maintained throughout the survey. Unless otherwise specified, all azimuth determinations are accomplished with the solar apparatus. All measurements are made with a Lallie steel tape, 5 chains in length, compared with a Lufkin standard 1 chain tape and found correct. The measurements are made on the slope, the vertical angle determined with clinometer or transit, and the slope measurements properly reduced to true horizontal distances for entry in the field notes.

The elevations are obtained by barometer readings carried in by Cadastral Engineer Blout and Surveyor Warboys; compared and agrecing very closely with several other readings brought

in by different individuals.

GENERAL DESCRIPTION.

The pottion of T. 5 N., R. 22 E., surveyed under this group, comprises an area 4 miles square in the southeast part of the Tp.

A large portion of the land is mesa with some mountains in the extreme SE. and NW. parts. A rough, lava capped ridge extends in a general N. and S. direction through the central portion of the area surveyed.. The No Fork of the White River enters the Tp. near the \frac{1}{4} sec. cor. on E. bdy. of sec. 13 and flows in a general southwesterly direction; the E. Fork of White River enters the Tp. in S. part of E. bdy. of sec. 25 and flows in a gen eral westerly direction to its junction with the N. Fork in the NW. corner of sec. 35; these two branches form the White River, flowing in a southwesterly direction, which leaves the Tp. in the SE. corner of sec. 33. All the land surveyed is tributary to these two streams.

The soil is mostly rocky and gravelly, with a layer of a-dobe, clay and loam on the surface.

The timber is mainly juniper, pinion and oak, with some cottonwood, walnut, alder and willow along the river bottoms. There is no timber of present commercial value for purposes other than fire wood.

The undergrowth comprises scrub oak, mountain mahogany, manzanita, cat claw, wild locust, buck brush, and cacti of various kinds.

All of the land is within the boundaries of the Fort Apache Indian Reservation and a number of Indians reside in the There extreme S. and E. portions of the area surveyed. is a comparatively small amount of land cultivated as most of the soil is too shallow to produce a crop. No water is available for irrigation of the mesas without lifting it a considerable distance or by building a can al from a lond distance up stream. Cattle and horses al from a lond distance up stream. graze over a considerable area during favorable seasons. The elevations range from 4800 to 6000 ft. above sea level.

The town of Whiteriver is located in secs. 12 and 13 and is the headquarters of the Fort Apache Indian Reserva-The Theodore Roosevelt Indian School, for Indian children, is located at Fort Apache in the N. portion of
