CHAINS

The south boundary was surveyed in 1884 by L. Wolfley. The north boundary (the First Standard Parallel South) and the east boundary was surveyed in 1875 by T. F. White. The west boundary and subdivisional lines were surveyed and the north, south and east boundaries resurveyed in 1900 by P. Contzen. The east boundary was resurveyed in 1916 by A. B. Rich and iron posts set on the north five miles, referring to Township 6 South, Range 24 East only, with iron posts on the south one mile set as common corners. The standard quarter section corner of section 36, Township 5 South, Range 23 East, was also remonumented with an iron post in 1916. The west boundary was retraced in 1924 by G. F. Sawyer.

The following notes are those of a dependent resurvey of the north boundary (the First Standard Parallel South), the east, south and west boundaries, and the subdivisional lines of Township 6 South, Range 23 East, Gila and Salt River Meridian, Arizona, designed to restore the corners in their true original location according to the best available evidence.

This survey was executed in accordance with the specifications set forth in the Manual of Surveying Instructions 1947, and the Special Instructions dated January 30, 1967.

Only the true line bearings and horizontal distances for the surveyed lines are given in these notes. Unless described, each corner was monumented with a standard iron post, 30 inches long, $2\frac{1}{2}$ inches in diameter, flanged at the base, and with a brass cap riveted to the top.

The geographic position of the southeast corner of the township is: Latitude, 32°51'38" North and Longitude, 109°56'10" West. Calculated from a direct tie made to Triangulation Station MAT, located near the center of section 11.

The mean magnetic declination was found to be $13\frac{1}{2}^{\circ}$ East.

General Description

Township 6 South, Range 23 East, lies approximately 9 miles west of Pima, Arizona. The elevation ranges from about 2900 feet in section 1 to about 3550 feet above sea level in section 31. Most of the township is gently rolling land becoming slightly broken in the SW.portion.

The soil is gravel clay loam, which supports a moderate growth of creosote, sagebrush, cacti, cat claw, mesquite and bunch grass. Livestock grazing is the primary interest at present.

Range improvements noted within the township were spreader dikes for erosion control and two test plots, one bet. secs. 13 and 24, the other bet. secs. 35 and 36.

Aravaipa and Klondike road enters the township in section 1, traversing southwesterly leaving the township in section 31.
