#### CHAINS

The following field notes are those of the dependent resurvey of a portion of the south and north boundaries, a portion of the subdivisional lines, and the subdivision of sections 26 and 27.

That portion of the east boundary of the White Mountain Indian Reservation within this township, and the township boundaries and subdivisional lines outside of the White Mountain Indian Reservation, were surveyed by W. R. Fitzgerald, Deputy Surveyor, in 1883. The north boundary of the White Mountain Indian Reservation, within this township, was surveyed by Jesse B. Wright, U. S. Deputy Surveyor, in 1906. William B. Kimmel, U. S. Surveyor, resur veyed that portion of the east boundary of the White Moun tain Indian Reservation within this township, in 1913, and resurveyed a portion of the south boundary of the township in 1916. The east and north boundaries of the township were resurveyed in 1940 by Frank Motoh, Public Land Surveyor, Ty White, Assistant Cadastral Engineer, and Claude F. Warner, Assistant Cadastral Engineer. Certain cadastral survey corners on the boundary of the White Mountain Indian Reservation were remonumented by John H. Witmer, Cadastral Surveyor, in 1969, and Marlin G. Livermore II, Cadastral Surveyor, in 1970.

This survey was executed in accordance with the specifications set forth in the Manual of Surveying Instructions, 1973, and the Special Instructions for Group No. 580, Arizona, dated September 19, 1975.

Preliminary to the resurvey, the lines of the original survey were retraced and search was made for all corners and other calls of the record. Identified corners were remonumented in their original positions; lost corners were restored and monumented at proportionate positions based on the original record. The retracement data were thoroughly verified and only the true line field notes are given herein.

The directions of lines were determined by direct solar observations, and refer to the true meridian.

The geographic positions of the corner of sections 1, 2, 35 and 36, on the south boundary of the township, as scaled from the advance sheet of the Geological Survey quadrangle map, NUTRIOSO 2 SW., ARIZ., prepared in 1958, is as follows:

Latitude 33° 51.8' N. Longitude 109° 27.3' W.

The mean magnetic declination is 13° E.
