	The following field notes describe the dependent resurvey of a portion of the south boundary and a portion of the subdivisional lines, and the metes-and-bounds survey of the Mount Nutt Wilderness Area Boundary, in Township 20 North, Range 19 West, Gila and Salt River Meridian, Arizona.
	The history of surveys pertaining to this resurvey is as follows: The Fifth Standard Parallel North through Range 19 West was surveyed by Omar H. Case in 1872. The Fifth Standard Parallel North through a portion of Range 19 West was resurveyed by Fred W. Rodolf in 1910. A portion of the south boundary and subdivisional lines were surveyed by William B. Alexander in 1910-12. The Fifth Standard Parallel North through a portion of Range 19 West was resurveyed by Guy H. Richardson, Otis Ross, and Hugo Price in 1915. The west boundary was surveyed by Guy H. Richardson in 1915. A portion of the south boundary was retraced and surveyed by Hugo Price in 1915. A portion of the subdivisional lines was resurveyed and surveyed by Guy H. Richardson and Hugo Price in 1915. The south boundary was dependently resurveyed by Dennis K. McKay in 1984-90.
	The survey was executed in accordance with the specifications as set forth in the <u>Manual of Surveying Instructions, 1973</u> , and the Special Instructions dated October 24, 1991, for Group No. 738, Arizona.
	Preliminary to the resurvey, the lines of the original survey were retraced and search was made for all corners and other calls of the record. Identified corners were remonumented in their original positions; lost corners were restored and monumented at proportionate positions based on the original record. The retracement data were thoroughly verified and only the true line field notes are given herein.
	The purpose of this survey was to determine the boundary of Mount Nutt Wilderness Area.
	The directions of all lines were determined by direct hour angle observations on the sun and Sirius, and refer to the true meridian. Distances and angles were measured with a Zeiss Elta 3 total station instrument.
	The geographic position of the southeast corner of section 33 on the S. bdy. of the Tp., as determined and published by the U.S. Geological Survey, is as follows:
	Latitude: 35°04'08.936" N. Longitude: 114°17'52.006" W. NAD27
	The mean magnetic declination, as taken from quadrangle map MOUNT NUTT, ARIZ. and SECRET PASS, ARIZ., published in 1967 by U.S. Geological Survey, is 15° E.
